This document provides the instructions and questions that will appear on the 2022 Placed Camp Questionnaire for reserved camping in Black Rock City. You must complete the actual questionnaire through your Burner Profile online at <a href="http://profiles.burningman.org/participate/brc/">http://profiles.burningman.org/participate/brc/</a>. We recommend reviewing this document thoroughly and drafting your responses in a separate document before completing the online form. The questionnaire opens on February 15, 2023.

## **Placed Camp Questionnaires Due**

For theme camps, villages, and all camps within a village Thursday, March 30, 2023 @ 12 Noon Pacific Time

You can expect notification of placement decisions via email by early-June. If your camp is not selected for placement, you are welcome to set up in open camping after the Gate opens.

Multiple volunteers on the Placement Team review every questionnaire. If you are a long-standing theme camp or village, we recommend that you complete the questionnaire assuming we will be seeing the information you provide for the first time. Please review and update your questionnaire each year as needed.

## Camp Lead, Placement's Main Contact

The person who fills out this questionnaire will be Placement's main point of contact for any questions or issues regarding your camp and will be referred to as the Camp Lead or Village Mayor. We will contact them using their Burner Profile email; please make sure it is up to date on the previous page. Due to the large volume of emails, Placement will only correspond with the Camp Lead/Village Mayor. The Camp Lead/Village Mayor is responsible for resource distribution (i.e. if applicable - Stewards Sale tickets, Work Access Passes, camp placement location) and they will receive all camp-specific announcements. Placement will not intervene in internal camp disputes.

A Camp Lead can change after the Placed Camp Questionnaire is submitted by having the current Camp Lead email <a href="mailto:placement@burningman.org">placement@burningman.org</a> to give us permission to change this information. The email must come from the Burner Profile submitted in the questionnaire, with the new camp lead's Burner Profile CC'ed. The new camp lead must respond and confirm the change to complete the process.

Camps/Villages should also identify additional contacts on the questionnaire. If a Camp Lead is unresponsive or a placement-related issue arises, such as requiring more information about the camp, the Placement Manager will rely on information from these additional contacts on behalf of the camp.

## **Layout Plan Uploads**

Please prepare your camp layout plan prior to starting your Placed Camp Questionnaire. You can find instructions and samples on the Theme Camp and Village <u>Layout Plan Criteria & Sample</u> page.

Layout plans are required to complete the Placed Camp Questionnaire. Please do not use a "placeholder" file, as this could disqualify your questionnaire. We need your actual plan for the current year within your questionnaire. (Camps within Villages are not required to upload a separate plan — their plans should be incorporated into the Village plan). If your layout changes after submitting your questionnaire, you can send updated plans to placement@burningman.org.

#### Final Instructions

You may save and return to your questionnaire as often as you need by using the "Save and Continue" button at the top of the questionnaire screen.

We highly recommend drafting your answers in a separate working document (like a MS word or Google doc) and then copy-pasting your answers into the questionnaire when you're ready to submit everything. Some internet browsers may time out this webpage, causing you to lose your work.

#### Remember - you must SUBMIT your questionnaire before:

- March 30 @ 12 noon Pacific Time for returning theme camps/villages and camps within a village.
- April 20 @ 12 noon Pacific Time for all support camps.
- We highly recommend beginning a questionnaire at least 2 weeks before it is due.

We know that unexpected things can happen in life so be sure at least one other person in your camp besides the Camp Lead is aware of the deadline and can take over the questionnaire if needed.

Once you submit your questionnaire, you will receive an email confirming the receipt of your questionnaire. If you do not receive an email, it means we DID NOT receive your questionnaire and there is likely an error on your end. Every year we get emails after the deadlines from camps who thought they submitted questionnaires, but were never fully submitted.

If you don't receive a confirmation email, go back into your "Save and Continue" link to complete and submit the form. If you are sure you submitted but still don't receive a confirmation email, reach out to us at <a href="mailto:placement@burningman.org">placement@burningman.org</a> BEFORE the deadline.

#### **Technological Requirements**

Due to functionality issues, please do not use a mobile device to file your placement questionnaire. If you have technical issues with the form, please reach out via the <u>Contact Us</u> link in the Profiles menu above.

The only way to submit answers to the questionnaire is through the online form. Please DO NOT mail or email your questionnaire answers. This does not give us all the information we need. We will only accept Placed Camp Questionnaires via the online form. Thank you!

## **Theme Camp**

An interactive camp that is approved by the Placement Team based on the <u>Theme Camp Criteria</u>. Resources such as Work Access Passes (WAPs) are provided by the Placement Team.

#### Village

A village is made up of two or more theme camps and any additional sub-camps joining together to share resources. Village populations must be 38-50 people or more. They can be a mixture of theme camps and support camps (art, mutant vehicle or work support). If the village has only two sub-camps, they must both be theme camps.

The Village Mayor communicates with Placement and manages the distribution of Work Access Passes (WAPs) provided by the Placement Team. Tell us how many and list which camps are within your Village at the top of the Interactivity section below.

Camps within Villages are required to complete a Placed Camp Questionnaire, too. If you are a Village Mayor, please instruct the leads for each of the camps within your village to submit a questionnaire for their camp.

## Camp within a Village

Completing this Placed Camp Questionnaire is required for all sub-camps within Villages, regardless of their category. These camps should select Camp within a Village as their camp category and will be asked what type of camp you are (theme camp, art support, mutant vehicle support, etc.). This questionnaire captures details of your participation and offers the opportunity for your camp to be listed on the Burning Man website. It also helps the Placement team understand the full interactivity of your Village. Stewards (formerly Directed Group Sale) tickets and Work Access Passes for theme camps within villages will come from the Village Mayor.

#### Art Support Camp

If you have or will register an on-playa Art Installation with the Art Department, you can request an Art Support Camp for your group's reserved camping. An Art Support Camp is for the art installation build crew and their essential support crew only. You will be asked for the name of your art piece and the number of people who will be camping at the camp. Resources such as Work Access Passes for the art installation are provided by the Art Department (not from Placement). Please note that Art Support Camps must be affiliated with a registered art installation and must complete the Art Installation Questionnaire for your art to be placed by the Art Department.

## **Mutant Vehicle Support Camp**

If you have or will apply for a Mutant Vehicle license from the DMV, you can request a Mutant Vehicle Support Camp for your group's reserved camping. A Mutant Vehicle Support Camp is for the mutant vehicle build crew and their essential support crew only, per the <u>population criteria</u> and can be no larger than 200'x200. You will be asked for the name(s) of your mutant vehicle(s) and the number of campers. Resources such as Work Access Passes for your mutant vehicle are provided by the DMV (not from Placement). Please note that Mutant Vehicle Support Camps must be affiliated with a licensed Mutant Vehicle and must complete the Mutant Vehicle Application to receive a license from the Department of Mutant Vehicles. If your vehicle is not approved by the DMV, your mutant vehicle support camp will not be offered placement.

#### **Work Support Camp**

If you are working for a Burning Man Department on playa, you can request a Work Support Camp for your group's reserved camping. At least half of the campers must be active staff (staff includes volunteers!). Resources such as Work Access Passes are provided by your Burning Man Department Manager (not from Placement). Department managers must verify your status as active staff to qualify for this category.

#### **Burning Man Department**

A department camp is an official reserved space for Burning Man Project Departments to operate on playa. Department camps must be pre-approved by Event Leadership and the Placement Questionnaire can only be submitted by designated Burning Man Project staff.

To honor our principle of <u>Decommodification</u>, you must not use or include the name of your commercial business or enterprise in your camp name. Burning Man is not a festival; camps of any type cannot sell products or services or promote any commercial endeavor in connection with their activities in Black Rock City. For example, if you're a group of people who work together somewhere, your company or organization cannot be represented in the name, paraphernalia, or interactivity of your camp.

If we discover your camp name is the same as a business or enterprise you're affiliated with, we will ask you to change the name of your camp or will deem you ineligible for placement.

# NEW Humans Uniting for Better Sustainability (HUBS): Sharing Power and Other Resources

As part of the effort to make Black Rock City more environmentally sustainable and in the spirit of communal effort, we encourage camps to share infrastructure like power, transportation, heavy equipment, and other resources. To offer a resource or find other camps to partner with, we highly encourage you to utilize <a href="Spark">Spark</a>, a Burning Man collaboration tool.

While Placement has always tried to put camps together who requested to be neighbors, the HUBS process gives priority to camps who are partnering to efficiently share resources such as power, water, and transportation. Rather than rely on Placement to determine your neighbors and leave resource-sharing up to chance, you can collaborate and form partnerships with other placed camps.

Most BRC blocks have a depth of  $\sim$ 250'. Esplanade to A and E to F are  $\sim$ 400-450' deep. Average length of full blocks is around 1000'.

  - o OR They are part of the PETROL Fuel Program and require servicing of a generator/fuel tank that is further than 20' from the street or are within 20' but have obstructed access
- Indicate where adjacency between specific camps is necessary.

- Upload only a one-page HUB layout here.
- Maximum file size: 10 MB.
- Accepted file types: .jpg .jpeg .pjpeg .png .pdf.
- You must convert .heic format photos to jpeg before uploading. There are many <u>free websites</u> that offer this service.
- Filename must not have spaces.
- The file extension (i.e., .jpg) must be included.
- You must use a computer (not a phone or tablet) to upload your images.
- You must have JavaScript enabled. If you need help with that, see: enable-javascript.com.

If you are on a mobile device, please use Save and Continue and finish this section of the form on a computer. This is a required question, but may not function as such on a mobile device. If you do not upload your final layout plan, your questionnaire cannot be processed.

We must see your plans for happenings, service, gifting and/or hosting in great detail. ## Public Water Use at Burning Man

Contact with untreated waste wash water, aka "gray water" is a health risk, and of course should be avoided.

Large quantities of water (250 gallons+) being used for projects that entail full body contact or consumption by people must be "potable" and come from Nevada State Health Division approved sources.

Water being used for misting systems and in ways that do not involve consumption do not need NSHD clearance. However, it is wise to make sure that you have "potable" water and the source is reputable!

Public pools and showers that hold or recycle water – those allowing contact with contaminated gray water – will not be permitted. Art pieces involving water are not considered showers unless they are labeled such and encourage bathing.

## **Decommodification At Burning Man**

As a citizen of Black Rock City and a camp lead, you help create a decommodified zone. The playa is a space free from advertising and transactional relationships, not beholden to corporate influence. It's one of the most important ways the Black Rock City experience is different from the other 51 weeks of the year, and we all play a part in helping keep our city unique.

This continues when we're off the playa too! Over the last few years, we've seen an increase in people posting photos from BRC on Instagram tagging the brands they're wearing or promoting products they brought with them. The playa is not a backdrop for your business! You may not use Burning Man, Black Rock City, or any imagery from the event to promote a product, service, or brand. That means your furry coats and sparkly boots, your hats and headdresses, your necklaces and glasses, your masks and LED trinkets, your e-bikes and scooters... the list goes on.

Using the event for marketing purposes is not just a violation of <u>Burning Man's Principles</u>, but also of our <u>ticket terms</u> and <u>conditions</u> (to which everyone agrees when they go to Black Rock City), <u>BLM's commercial filming policy</u>, and the <u>criteria</u> for your camp to be in good standing with the Placement Team.

The people violating this important principle live in camps, and part of the responsibility to educate and prepare Burners starts with camp leadership. Camps are where the acculturation around <u>Decommodification</u> happens. We need your help to uphold this important principle with your entire camp.

WAPs are not transferable and are only for those who are working on the camp to which they are assigned, per our good standing criteria.

Fuel Storage is classified separately from "fuel in use". Fuel in use includes fuel in generators, external tanks plumbed to generators, fuel tanks connected to RVs or trailers and classified for cooking, fuel tanks connected to shower trailers, and fuel containers connected to a flame effect system. This fuel amount is not counted towards total fuel stored in a camp, art piece, or mutant vehicle.

Fuel storage includes any fuel in your camp that is not classified as "in use" and comprises both liquid fuels and propane. Fuel storage areas must follow a number of guidelines including a maximum storage limit of 110 gallons, separation of the storage of liquid fuels and propane, and 100 feet of distance between neighboring fuel storage areas. All stored liquid fuels must have secondary containment, not providing this is a ticketable offense by the BLM.

The hillsides around Black Rock City are high fire risk status so Sky Lanterns are forbidden at any time during the event and may result in fines from the BLM and/or Pershing County Sheriff's Office.

#### PETROL Department: BRC Fuel Safety Program

One of the ways you can help us protect the playa is by storing as little fuel as possible in your camp. Each point of transfer is a risk of spill, fire or worse. The BRC Fuel Safety Program is available to minimize the amount of fuel you are transporting from outside of Black Rock City. This program is run by the PETROL Team.

There are two ways to participate in the program – by delivery to your camp, or by pickup at Hell Station, which is located beyond 9:30 & K. Both require registration and approval by the BRC Fuel Program.

Dyed diesel is available for delivery to theme camps with large, diesel-powered generators that will take 30 gallons or more per delivery. If you have a small diesel generator, or one that runs on gasoline, you can fill up your CARB and EPA certified fuel containers at Hell Station and transport them back to your camp, or request a fuel drum delivered to your camp to self service your generator.

Propane is available for delivery to Theme Camps on the Esplanade, 2:00, and 10:00 roads for tanks of 100 lb. or greater capacity. Smaller cylinders and tanks can be filled at the Hell Station during normal hours of operation and transported

Important: driving once inside the event is not allowed (except for specially licensed vehicles) and this rule is strictly enforced. Use a handcart, trolley, or make friends with your neighborhood mutant vehicle to pick up fuel at Hell Station. Secondary containment for the transport is required.

Art Projects and Mutant Vehicles may sign up for fuel through their respective applications.

The BRC Fuel Program has limits to the number of generators it can service per day. Each truck can only handle a certain number of stops. If you know your needs for fuel delivery we suggest you apply early as there will be a cut-off once that limit is reached.
